1. One time registration fee is RM50 (one program)/RM80 (unlimited programs). If stopped for more than 2 months, then re-registration is required. This registration fee may not be applicable to certain workshops/courses.

4. First payment is due at the time of registration and prorated accordingly. Subsequent payment is due on the first week of the next quarter/month or level or preset class dates. Late payment charges apply.
5. One month notice is required to change or leave an activity program.
6. Terms for workshops/courses:
 - a) Registration is subject to receipt of payment in full before date of event, for full confirmation*.
 - b) Cancellation of confirmation* shall be in writing, faxed or emailed and a 75% refund is allowed if cancellation is at least seven (7) working days before the event.
